SOUND OUTREACH

Sound Outreach (SO) offers free guidance, direction, and support to economically vulnerable families in South Puget Sound, helping them secure financial stability and independence. We assist people to realize long-term financial goals by providing guidance with increasing household income, improving credit scores, and achieving livable-wage jobs.

We are determined to actively seek out disenfranchised neighbors and disrupt systemic financial and social racism by empowering residents most in need. We will continue to offer a safe space to learn and grow new generations of wealth previously limited through economic inequality.

SO is humbled to serve alongside our clients and we are thankful for the dedication and support from our community.

2022 a Year of Offering Options

During 2022, Sound Outreach worked to strengthen its existing programs in support of individuals, families and businesses. We made sure they had all the options to make the best financial decisions for themselves.

- Served 2,327 clients and for clients that reported their income, 70% had income levels considered "crisis" or "vunerable".
- County-wide outreach for Washington's new Working Families Tax Credit which puts up to \$1,200 in household pockets.
- ✓ Officially opened the Sumner-Bonney Lake Center for Strong Families Finanical Opportunity Center.
- Bank On Pierce County secured its first credit union accredited account.
- Formed a partnership with the Black Collective to hire a business operations specialist supporting Black businesses.
- Raised more than our \$70k goal with the return of the Sound of Progress luncheon and over 200 guests.

FINANCIAL COACHING **Program**

Sound Outreach (SO) has a network of trained financial coaches, embedded in organizations throughout the south Puget Sound, who provide long-term financial coaching. SO puts consumers in charge of their money by going beyond financial education to help improve their financial stability.

Our financial coaching services are free and we meet one-on-one with clients to:

Make a Budget: Help clients know exactly where their money goes in order to create a realistic plan toward stability.

Credit Report: Collaboratively review the credit report and make a plan to build credit and increase clients' credit score.

Financial Health Assessment: Review the clients' overall financial health.

Clients' Financial Vision: Establish our clients short-term and long-term goals and figure out the first steps toward attaining them.









WORKING FAMILY TAX CREDIT

In 2022, SO was chosen as one of three Pierce County organizations to partner with the Department of Revenue for outreach and local assistance for the Working Families Tax Credit. This included a full time staff member, Alejandra Villeda for the duration of the project as well as a budget to complete multilingual outreach efforts to low-income families. LATRAIA'S STORY

Latraia moved to the Pacific Northwest from Florida in 2019 with the dream of owning her own home. When Latraia came to Sound Outreach in 2021 she was living in a tiny home village for unhoused individuals and hoping to map out a path to home ownership.

While meeting with her Financial Counselor, Brandon, she gained the knowledge and resources to meet her savings and budgeting goals. Latraia also credits the accountability provided by Brandon during their meetings as one of the main reasons she was able to meet her savings goals and was ready to jump when the opportunity came up to buy her first home in Kent!

Center for STRONG FAMILIES

The Center for Strong Families (CSF) bundles together employment and financial coaching, as well as access to streamlined public benefits through comprehensive case management for economically vulnerable households. Partially funded by United Way and working with multiple stakeholders and partners, our counselors have helped hundreds of clients secure better jobs at higher wages, build up sound financial habits leading to higher credit scores, and save their income through budgeting and goal-setting techniques.

*ALICE stands for Asset Limited, Income Constrained, Employed, and is a new way of defining and understanding the struggles of households that earn above the Federal Poverty Level, but not enough to afford a bare-bones household budget.

BANK ON & Pierce County Asset Building Coalition

The Pierce County Asset Building Coalition (PCABC) meets quarterly to bring more access to banking services. Building collaborations between the financial sector, social services, and government. We seek to better serve youth, BIPOC communities, and seniors with safe, affordable, and accessible banking services.

The Bank On Pierce County program started in 2021 and expanded access throughout Pierce County to nationally certified accounts that are safe, affordable, and accessible.

FIRST PIERCE COUNTY CERTIFICATION

In 2022 with SO's assistance, America's Credit Union received Bank On certification, making it the first Pierce County based credit union to receive certification.

Working with Sound Outreach's financial and employment coaches 40 of our clients saw their net income increase by an average of \$1,878 per month.



SHIBA PROGRAM

The Statewide Health Insurance Benefits Advisors (SHIBA) is a free, unbiased, and confidential counseling service offered by the Washington State Office of the Insurance Commissioner.

Sound Outreach has 24 trained volunteers ready to help consumers understand their Medicare rights and options. We offer information on Medigap (Medicare Supplement) and Medicare Advantage plans, Medicaid programs, employment-related health benefits, longterm care options, fraud and abuse, and much more. We also answer questions, make referrals, help evaluate and compare health insurance policies, and make public presentations.

SILVER FINANCIAL COACHING

The Silver Financial Counseling Services program provides Tacoma senior citizens 60 and over with safe and secure access to a financial counselor to assess their financial situation, as well as assistance navigating government and community resources specific to seniors.

Before the pandemic, 40% of adult Americans did not have \$400 in savings for emergencies. In 2022 Sound Outreach saw 41 of our clients create an average of \$8,393 in savings.

SOUND outreach

Pierce County's HUB AND SPOKE PROGRAM

Pierce County has teamed with Sound Outreach/ Tacoma Pierce County Black Collective as one of seven organizations to reach BIPOC business owners. The County acts as a hub for dispersing information and the organizations are the "spokes", sending out navigators to the community.

Our navigator works to increase the list of blackowned businesses, mostly through word of mouth, and relationship building. He also puts on various "Collective Development" events where black business owners can come in for free business development sessions from prominent businesses and organizations that have specific assistance available for black business owners.
